Reservation policies

Please note that we may not be able to give you the type of room selected. If the type of room selected is no longer available, we will assign another one without prior notice. Also, it will not be possible to accept any special demand to share the same condo unit. Finally, no change of room will be allowed on site.

Payment policies

Upon reception of your form, we will take a deposit on your credit card representing 25% of the total cost of your stay as guarantee. The balance of the payment will be taken 24 to 72 hours before arrival. If this final payment needs to be taken on a different card, please advise us when you send this present form. An invoice and proof of payment can be provided on site if needed. Please note that if you share a room for which there is only one credit card on this form, this card will automatically serve as deposit and as final payment for both participants.

Cancellation policies

The deposit is non-refundable but considered as a credit to your account for a period of six months if the cancellation is made more than 30 days prior to the arrival date. If the cancellation is made less than 30 days prior to the event, the deposit will be lost without exception. In the case of a cancellation within 15 days of the event, accommodation fees will be charged. If the cancellation is made 2 days or less before arrival, the entire package will be charged.

Establishment policies

The property is entirely non-smoking, and pets are not allowed. By signing this form, I agree to pay the costs incurred in case of noncompliance with these regulations or of any damage caused to the establishment during the stay.
